Dear Craft and Food Vendors,

We invite you to be a part of our 2017 Czech Festival Arts & Crafts Show!

The Wilson Czech Festival is one of the largest festivals in Ellsworth County Kansas. Hosted by the small rural community of Wilson, total population under 800, the festival is known to bring in thousands from all across Kansas and neighboring states. The Czech Festival promotes and honors the Czech heritage, encourages community and family involvement and helps create lasting memories for young and old. The festival also provides programs and activities that are appealing and appropriate for all ages that are designed to attract tourist to our rural community therefore financially benefiting not only local businesses but surrounding community businesses as well.

Enclosed, please find a 2017 Arts & Crafts Vendor Application and Lot Map. Each block on the map represents 1 (one) lot that is 10 ft. x 10ft. **The pre-registration cost per lot is \$30.00 which expires May 31, 2017.** Cost per lot following the deadline is \$40.00. The fee per lot reserves your lot for both days of the festival. Lots will be reserved in the order in which applications (with payment) are received.

To keep our event profitable for our vendors, the festival committee reserves the right to limit or deny any duplicate merchandise, services, or menu items. Booth fees are nonrefundable. All food vendors must submit a menu with prices along with their applications. All decisions on food vendor applications and vendor placing will be at the discretion of the committee. Food vendor applications must be received no later than May 31, 2017 for review.

Confirmation packets will be mailed with an event schedule, late June to early July.

Please come as early as you need to allow yourself enough time to set up before the slotted times, on the date(s) of your choosing. Tentatively, Friday 3pm to dark and Saturday (setup 6 am – 9 am) 10 am to dark. Please keep in mind the later you wait Saturday morning to set up, the harder it becomes to access the park via vehicle to unload.

No portable tents, tables & chairs, extension cords, bug spray, etc. are provided. Please come prepared.

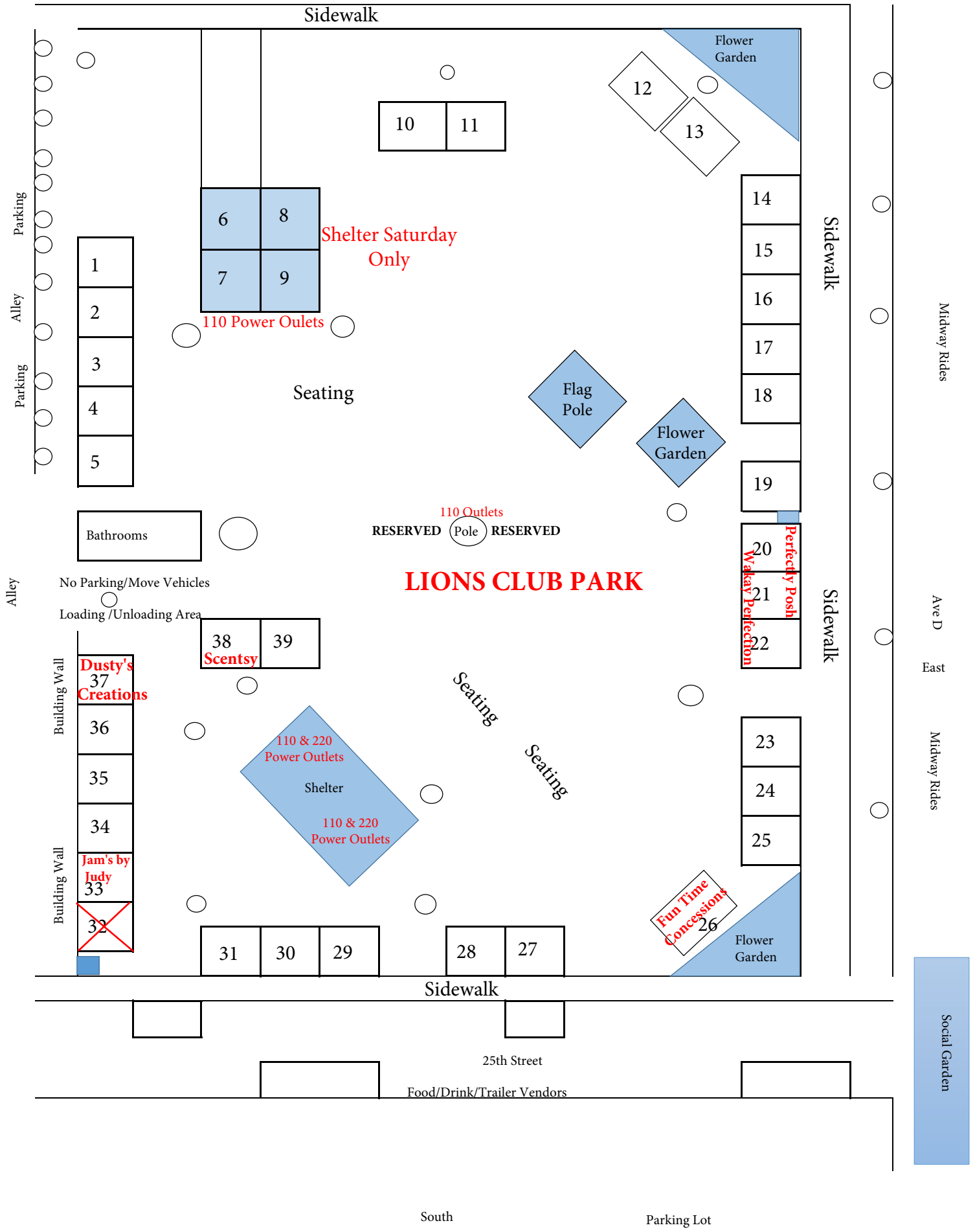
